Under new business

Asst. Chief Stewart- The District was contacted by the MSA office, the District is being required by the State Auditors office to conduct a year end audit of the district, due to the fact that the Board just hired our accountant, and the fact that district finances currently do not permit the district the ability to hire an independent auditor, I have asked for an extension to have audit submitted. We are to submit a letter of intent from the KFPD Board to have a 2yr end audit report submitted for the fiscal year ending

December 31, 2018 and 2017, the audit report is due by June 30 2019. The MSA Office would like the letter of intent to be submitted as soon as possible.

Asst Chief Stewart drafts up the letter of intent to have the 2yr end Audit completed and Director Falls and Director Reese signs the letter

Next item

Bond election update:

- -Chief Pryor: The Bonds passed, right now as far as the bond I am in talks with Bond Lawyers, so what we have to do is get the bond written so I'm shopping right now to see which Bond lawyer is going to give us the best deal once we get that then we'll bring it back to you to see what it will cost us to proceed.
- -Asst. Chief Stewart: While the Chief is shopping for the bonds myself and Battalion Chief Perry have formed a couple of committees, we have a truck committee and a firehouse committee. What these committees are going to do is kind of take the wheel and steer the direction of the developments and planning for the equipment and the fire house. Its just a select few of the guys who we feel have been active and can provide some valuable insight on building the trucks and building the station, so we've been in contact with several different manufacturers of fire trucks and we are looking for different architects and builders or what have you for the station. Until Chief Pryor secures the bonds were just shopping around and just looking right now, so in the mean time you may see a new fire truck or two come through because you know they are bringing out demos and taking us for rides and just letting us see their product. Other than that by the time the Chief gets the funds secured we will be able to roll full steam ahead and we'll have pretty much everything in place where we can do what we need to do.
- -Director Reese: As far as the new fire station is it going to be down where it is now or some where else
- -Chief Pryor: That's a great question
- -Director Falls: I hope it's on suburban Ave.
- -Chief Pryor: I'm in talks right now with the city uhm we had an agreement we wanted to leave it right where it was and take the old Post Office and expand that way but the city wants to do something different now, they want to put a police sub-station there, we're working hand in hand with the city and I'm trying to build relationships so you know we're looking at some property at Suburban and King streets, they will vote on it September 3,2018 and our next board meeting I will let you know the progress
- -Director Reese: I understand it will be a while
- -Director Falls: I'm excited about it passing
- -Chief Pryor: Now we're just doing our homework and trying to get with the city you know cause they have plans and you know we just gotta make sure our plans match
